Results from the 2013 National Salary Survey of NPs & PAs

▶ FOR THE SECOND YEAR since a blow to salary numbers in 2011, nurse practitioners and physician assistants saw increasingly higher wages from coast to coast. For PAs, Nevada clinicians saw the highest increase — a jump of 65.31% over last year's pay. PAs in eight other states saw increases exceeding 20% compared to 2012. Nurse practitioners were similarly fortunate in finances in 2013: Idaho NPs saw the highest increase at 32.62%. Just eight states showed a decrease in NP wages in 2013.

The two tables in this focused report list the average full-time salaries as reported by NPs and PAs in each state in 2013, with comparative data from 2012. *ADVANCE* also included the number of respondents from each state.
